BUDGET AMENDMENT NUMBER 1 TO CITY OF GRANITE SHOALS BUDGET FY 2021-2022

AN ORDINANCE AMENDING THE FISCAL YEAR 2021-2022 BUDGET (PASSED AS ORDINANCE #818 ON SEPTEMBER 14, 2021) FOR THE CITY OF GRANITE SHOALS, TEXAS, AND PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT, AND AN EFFECTIVE DATE.

Section 3. This Ordinance shall take effect immediately from and after its passage and publication as may be required by governing law.

Section 4. It is hereby officially found and determined that the meeting at which this Ordinance was passed and opened to the public and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
